We thank-you for your interest to lease our club facilities which we accept at a cost of **R3500.00**

We offer:

A full cash bar plus barperson(s)

Cleaner for before and after the function

20 x 4 seater tables and chairs

2 x TV's in the venue

Firewood is included, should it be required.

Sound system, should it be required; music can be loaded onto a USB – there is an additional cost of R500 for the hire of the sound system.

DJ's/Live music can be arranged by the Lessee.

However we must bring to your attention the following terms and conditions:-

1. Exclusivity is granted to venue area only. There is an outside area which can be utilised for additional seating. The venue can accommodate around 120 people including the outside area (weather dependent)
2. The boat moorings area and walkon area is a no go area.
3. The responsible person who is the signatory of this document will be held liable for all costs relating to any damages or any other unforeseen occurrence that may be transformed to become a club liability.
4. After the function the venue and outside area shall be left in an acceptable condition, and all private equipment, utensils and decorations shall be removed by 10h00 on the following day. The club and its staff will not be held liable for any losses of property.
5. Should the services of the restaurant be required, Nic Gunston, our in-house caterer can be contacted on 072 462 2676 to make arrangements. Should the lessee not be making use of our in-house catering, please be advised that all braai utensils, crockery, cutlery, dishes etc need to be provided – the club does not provide any of the above. Glasses are available with the bar facility, only with purchases from the bar.
6. We do NOT allow any alcohol to be brought onto the premises; should our bar staff find own alcohol brought in, this will be removed and returned to the lessee after the function ends. **BRINGING ALCOHOL ONTO THE ALREADY LICENCED PREMISES IS A CONTRAVENTION OF OUR LIQUOR LICENCE AGREEMENT.**
7. The venue is available for 6 hours or until 23h30, after which the lessee must reimburse the bar staff for additional hours at a rate of R150 per barman, per hour.
8. Please note that the Port is access controlled. PEDSAC are tenants of the Port, and therefore guests of PEDSAC must adhere to security arrangements of the Port.
